Facility Rules

Show Conduct: Sassy Strides shows will be run under a strict code of conduct. Riders will be found in poor standing if any of the following occur:

- A) Blatant disregard of the rules and safety.
- B) Failure to make good on insufficient funds within 60 days.
- C) Rude or Disrespectful behavior toward other competitors or event staff (Including Judge & Steward).
- D) The use of abusive or foul language toward anyone or any animal.
- E) Disregard for the well-being of the horse.
- F) Any bullying of any kind
- G) Under weight or malnourished horses, will not be allowed to show.
- H) Destruction of show grounds or property of any kind (this includes not cleaning up after your horse)

* If not compliant with show conduct, the show grounds and association have power to ban rider from events for up to a year at a time. We will have a **ZERO TOLERANCE** rule for inappropriate show conduct, these rules apply to all riders, spectators and all show participants.

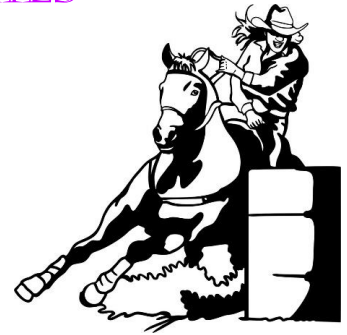
